ANNUAL REVIEW

Each year, on the anniversary of your appointment, you must:

- review your disclosures
- update your information
- take new compliance measures as needed

MATERIAL CHANGES

- Buying or selling a home or car
- Changes to your portfolios
- Acquiring or paying off a loan
- Assets over \$10,000 (e.g., inheritance)
- Friends or family with ties to the Government of Canada

Report within 30 days of the change.

GIFTS

Acceptable gifts:

- Permitted under the *Canada Elections Act*
- Given by family members or friends
- Normal expression of courtesy or protocol

Report acceptable gifts with an individual or cumulative value of \$200 or more within 30 days of acceptance.

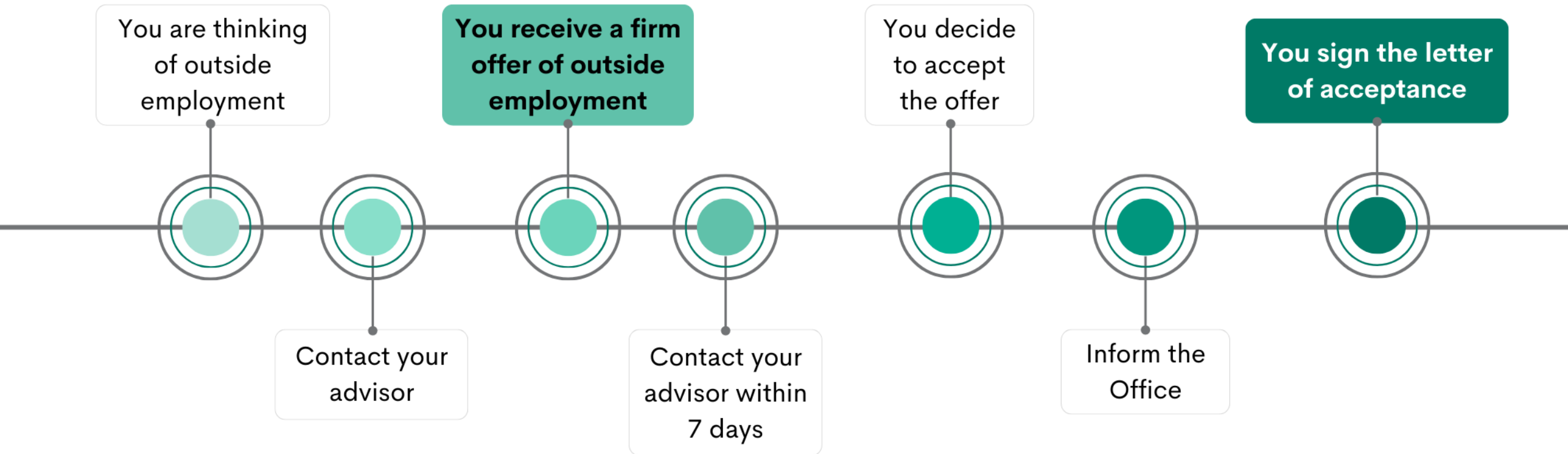


RECUSALS

- Recuse yourself from any discussion, decision, debate or vote where you would be in a conflict of interest
- A conflict of interest screen can be set up

Report recusal within 60 days.

OFFERS OF OUTSIDE EMPLOYMENT

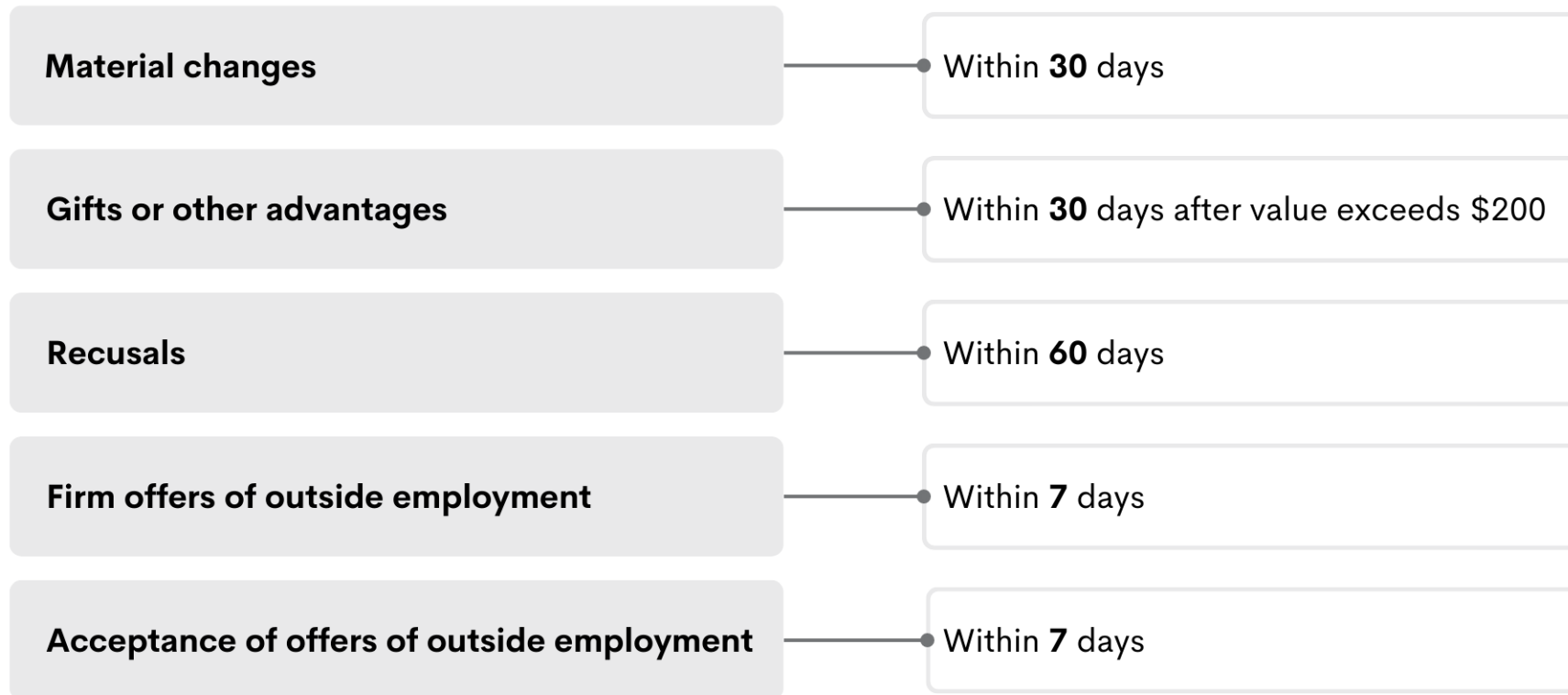
Report firm offers and acceptance within 7 days.

POST-EMPLOYMENT: REPORTING OBLIGATIONS

- Communications or meetings arranged with public office holders as defined in the *Lobbying Act*
- Meetings that you arranged, even if you did not attend


**Most former reporting public office holders
have a one-year cooling-off period**

Public Registry Home

The Office of the Conflict of Interest and Ethics Commissioner maintains a public registry of publicly declarable information under the [Conflict of Interest Act](#) and the [Conflict of Interest Code for Members of the House of Commons](#).

The registry is a searchable database. Start your search by using the links on the left. To return to our website, click on the "home" button in the top menu at any time.

NOTE: Once a Parliament is dissolved, triggering an election campaign, Members of the House of Commons are no longer considered Members and their public declarations are removed from the public registry. Following the election, publicly available information for new or re-elected Members will be posted on the public registry as they complete their initial compliance process under the Code. The Office will publish on a regular basis a *Members' Compliance Status Report* indicating the stage of each Member's initial compliance.
